# PMCA Pinnacle Scholarship Application for Current College Students

The Pinnacle Scholarship Fund was established by the Petroleum Marketers and Convenience Store Association of Kansas for the purpose of awarding scholarships to deserving students from within the industry.

## Eligibility

Each scholarship recipient must be one of the following:

- son/daughter or grandchild of a PMCA member;
- child of a full-time employee of a PMCA member; or
- employee of a PMCA member.



Applicant must be at least 17 years-old.

Applicant must have graduated from an accredited high school or have attained the equivalency of a high school diploma.

Applicant will be enrolled in a Kansas college or university as a full-time (12 hours minimum) student for the fall semester of 2019.

## Awards

Two \$1,000 scholarships will be awarded for 2019. Each recipient will receive \$500 per semester (second semester award is contingent upon achieving a first semester grade point average of 2.5 on a 4.0 scale as reported by the college's financial aid office). Awards are not automatically renewable for the second year; however, recipients may reapply to the program for the second year if they meet the academic requirements as specified above.

## Application

Each college applicant must complete the Pinnacle Scholarship Application and return it along with a current **official** college transcript of grades, 500-word typewritten letter outlining what you consider your most significant achievements and your educational and/or career objectives; letter of recommendation from college advisor or professor and letter of recommendation from PMCA member.

## Selection of Recipients

Scholarship recipients will be selected by a selection committee consisting of one PMCA member who is not a director and who is not related to any applicant, one college or university professor and one business man or woman not affiliated with the petroleum marketing industry in Kansas.

Selection committee will conduct a careful review of each applicant's academic standing, extracurricular activities, honors, and awards, 500-word essay of academic career goals and personal references.

## Payment of Scholarships

Checks will be mailed to recipient's address on the application and will be made payable jointly to the recipient and the school and must be endorsed by both.

Applications for 2019 Pinnacle Scholarships must be postmarked no later than February 28, 2019. Recipients will be notified by April 1, 2019. Check for the fall semester 2019 will be mailed to recipients prior to beginning of the fall semester.
